Background information

- summary consolidated cash flow statement and summary cash flow statement for the period from 1
 January 2018 to 30 June 2018,
- notes to financial statements.

Scope of the review

We conducted the review in compliance with National Auditing Standard 2410 in the wording of International Standard on Review Engagements 2410 Review of Interim Financial Information Performed by the Independent Auditor of the Entity adopted by Resolution 2041/37a/2018 of the National Chamber of

Certified Auditors of 5 March 2018.

The review of financial statements consists in requesting information mainly from persons in charge of financial and accounting matters, performing analytical and other review procedures, and assessment of

evidence gathered.

The scope of the review is significantly narrower compared to audit performed in compliance with National Auditing Standards in the wording of International Standards on Auditing. As a consequence, the review is not sufficient to gain confidence that all material issues that would be identified within an audit have indeed been disclosed. Therefore, we do not express an audit opinion on the aforementioned interim summary

financial statements.

Conclusion

Based on our review, we hereby conclude that our attention was not drawn to anything that might suggest that the accompanying interim summary consolidated financial statements and accompanying interim summary financial statements have not been prepared, in all material aspects, in compliance with the requirements of International Accounting Standard 34 *Interim financial reporting*, promulgated in the form of regulations of the European Commission.
